

WOW! Look what you accomplished You awarded these 26 students \$422,100 in scholarships



Thanks to the continued generosity and support of the Indian River County community, Scholarship Foundation awarded \$422,100 in new need-based financial aid on May 12, 2020 at its 55th Annual Awards Ceremony. Due to COVID-19 restrictions, the ceremony was held via Zoom webinar. Twenty six local students, including three recipients already in college and four high school seniors who are receiving their AA degrees from IRSC, will receive 61 scholarships to study at 15 colleges and universities in five states.

Richardson Awards Honor Brightest and Best

The presentation of the Richardson Scholar Awards is a highlight of each year's Awards Ceremony. Applicants for these awards, SFIRC's most prestigious and competitive scholarships, must demonstrate the highest levels of achievement in academics, service and leadership. Ten talented applicants competed for this year's awards. Nancy Richardson Luther and her daughter Kristin Luther Lockwood presented the awards to this year's recipients:

Diverse in their interests, these scholars share a passion for making the world a better place. The Richardson Awards were established more than 30 years ago by Nancy's family. Her father Dan Richardson was a founder SFIRC in 1965. The family began offering the Richardson awards in 1985 to "seek out and nurture potential decision makers who will have a future impact on our country and the world." Since then, more than 100 graduating Indian River County students have been honored as Richardson Scholars. In her address to the students, Nancy said, "I wish for you all to have a successful and happy life and to be kind to one another."

Scholarships Change Lives – Kimberley Toperzer

Kimberley, a SRHS student, was a 2016 recipient of the Grand Harbor Community Outreach and the Lois Cruze Memorial scholarships. At the time she needed an additional \$15,000 if she was to achieve her dream of going to college. She was a successful high achiever who selflessly gave her time to others. Her family was concerned because they did not have sufficient funds to help. Your donations made the difference! She graduated last year from the Florida Institute of Technology with a bachelor's degree in biomedical engineering and applied mathematics and is now employed by Lockheed Martin. New Scholarship


The Lisa Eckerd Colbourn
